CITY TICKET

SALES AND USE TAX
ELECTION

CITY OF YUTAN, NEBRASKA

“Shall the governing body of the incorporated municipality – the City of Yutan – establish a sales and use tax rate of one and one-half percent (1½%) upon the same transactions within such municipality on which the State of Nebraska is authorized to impose a tax, with all revenues generated by said one and one-half percent (1½%) tax to be used for public improvements, including public park and recreation improvements, within the City?”

FOR said sales and use tax
AGAINST said sales and use tax

A VOTE FOR: If a majority of the votes cast upon such question shall be in favor of establishing a local sales and use tax of one and one-half percent (1½%), then the City Council of the City of Yutan shall be empowered as provided by Section 77-27,142 of the Nebraska Statutes and shall forthwith proceed to collect a local sales and use tax rate of one and one-half percent (1½%) to be used for public improvements, including public park and recreation improvements, pursuant to the Local Option Revenue Act.

A VOTE AGAINST: If a majority of those voting on the question shall be opposed to such local sales and use tax rate of one and one-half percent (1½%), then the City Council of the City of Yutan shall not impose such a tax.

SAUNDERS COUNTY SCHOOL DISTRICT 0039
(WAHOO PUBLIC SCHOOLS)
IN THE STATE OF NEBRASKA
Tuesday, November 6, 2018

“Shall Saunders County School District 0039 (Wahoo Public Schools) in the State of Nebraska (the “District”) issue general obligation bonds of the District in an aggregate stated principal amount not to exceed Twenty-six Million Dollars (\$26,000,000), for the purpose of constructing buildings, additions and improvements on the existing middle school and high school campus and providing the necessary furniture, equipment, and apparatus for such buildings, additions and improvements; such bonds to be issued from time to time, to bear interest at a rate or rates and to become due at such time or times as may be fixed by, or at the direction of, the Board of Education; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?”
