BOARD OF SUPERVISORS PROCEEDINGS March 19, 2024

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, John Zaugg, Scott Sukstorf, Frank Albrecht, John Smaus and David Lutton present.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairman Lutton called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

Public Works Director reported on the following:

- ~Dirt Crew Cleaning ditches and reinstalling culvert 1st Street & CR K & CR 15. Shouldering CR 4 & Guard Camp Road this week
- ~Culvert Crew Working at Project (845) CR 9&10&P installing Twin 72'x51' CMPs on 10° skew RHB. Old Structure Is out and started back filling new structure. Moving to project (867) CR 13&14&S
- ~Contractor Project (817) CR 11&B&C Quad 12'x12'x74' concrete box culvert. Road is graded and rocked still needs to be seeded. The road will be open to the public soon.
- ~Contractor Project (872) Box culvert is completed and mainline is poured. Found 4 panels with cracks in them removed panels and re-poured them on Friday 3/8/24. Project needs to be seeded.
- ~Contractor Project (873) Walls, wings and stripped after 5-day break, request for doing a sand back fill was approved and started Friday
- ~Contractor Project (704) Federal Aid Bridge 4 Span 175' continuous concrete slab bridge. Trees are cleared out and started removing old structure
- ~NDOT is planning to start Round About HWY77-HWY 92-HWY 109 Junction on April 1st 2024 by Lake Wanahoo
