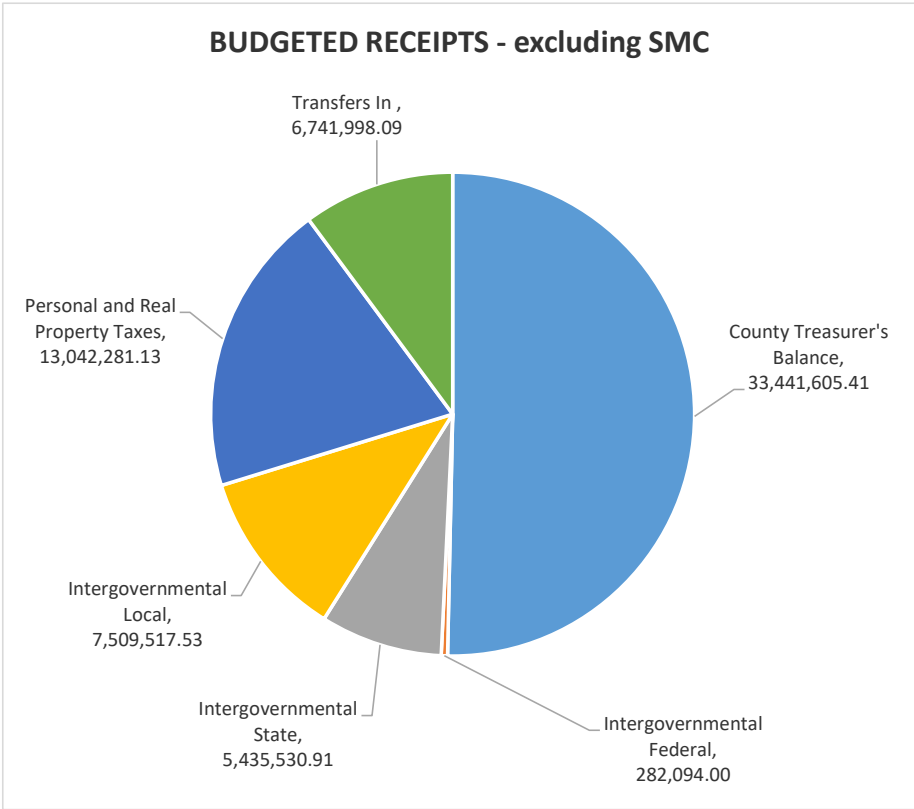

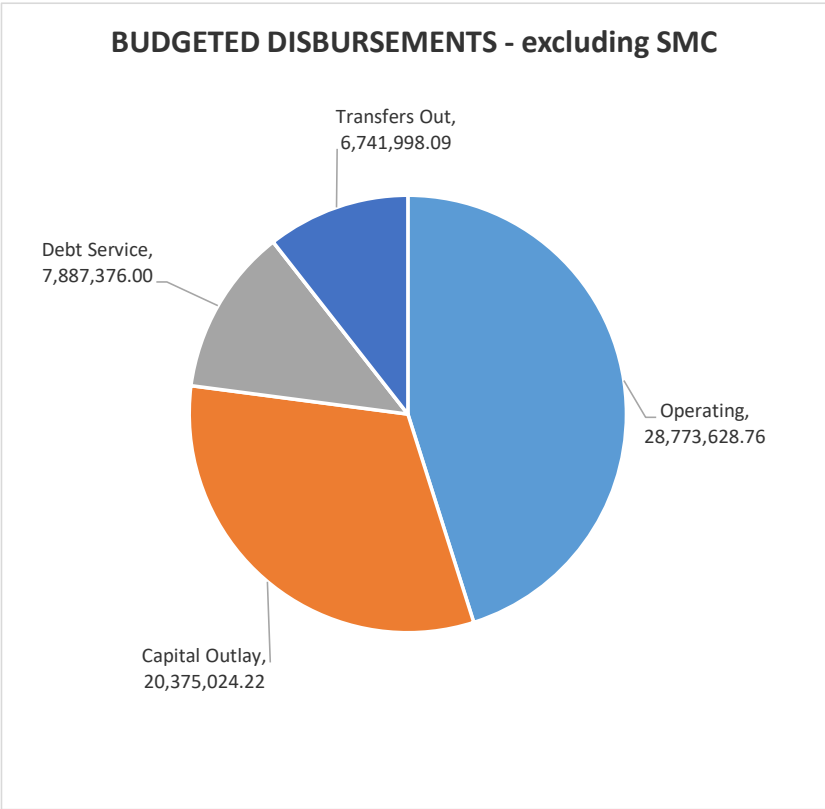
Examples of revenues received from the various sources, include:
