"Shall Saunders County School District 0001 (Ashland-Greewood Public Schools) in the State of Nebraska issue its general obligation bonds in a stated aggregate principal amount not to exceed Fifty-nine Million Nine Hundred Thousand Dollars (\$59,900,000), for the purpose of providing funds for construction and acquisition of a new elementary education school building and a new middle school with a competition gymnasium and fine arts auditorium, together with related site improvements and modifications to the District's existing facilities; and providing for the necessary furniture, equipment and apparatus for such facilities; such bonds to be issued form time to time, bear interest at such rate or rates, be sold at such prices, and become due at such time or times as shall be determined at the direction of the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"
