

**NOTICE OF SPECIAL BOND ELECTION
LANCASTER COUNTY SCHOOL DISTRICT 0161
(Raymond Central Public Schools)
IN THE STATE OF NEBRASKA
Tuesday May 9, 2023**

PUBLIC NOTICE IS HEREBY GIVEN to the qualified electors of Lancaster County School District 0161 (Raymond Central Public Schools) in the State of Nebraska (the “**District**”) that a special election has been called and will be held in the District on Tuesday, May 9, 2023, at which time there shall be submitted to the qualified electors of the District the following proposition:

“Shall Lancaster County School District 0161 (Raymond Central Public Schools), in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed Forty-one Million Eight Hundred Thousand Dollars (\$41,800,000), for the purpose of providing funds for: construction and acquisition of a new school building for preschool through sixth grade, site and public infrastructure improvements, renovations and modifications to the District’s existing buildings and facilities, and providing for the necessary furniture, equipment and apparatus for such buildings and facilities; such bonds to be issued from time to time, to bear interest at a rate or rates, become due at such times, and be sold at such prices as determined at the direction of the Board of Education; and

“Shall the School District cause to be levied and collected annually a special levy of taxes against all the taxable property in the School District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?”

FOR such Bonds and tax

AGAINST such Bonds and tax

Electors voting in favor of such proposition shall blacken the oval opposite the words “FOR such Bonds and tax” following such proposition, and electors voting against such proposition shall blacken the oval opposite the words “AGAINST such bonds and tax” following such proposition.

By-Mail Election – This election will be an election by mail. All registered voters residing within the Raymond Central Public School District will receive their ballot by mail at their address as it appears on the voter registration register and therefore no polling places will be open for voting. Ballots will be mailed by your respective County Clerk/Election Commissioner. Butler County Clerk, Lancaster County Election Commissioner, Saunders County Clerk or Seward County Clerk, between April 17, 2023 and April 28, 2023.

Voter Registration Deadlines –

1. **April 21st** – is the last day for mail in registrations, registrar registrations, delivered registrations and agency registrations Online Registrations prior to midnight. (**3rd Friday prior**)
2. **May 1st**- is the last day for in person voter registration in the office of the Election Commissioner or County Clerk (**6:00 p.m. 2nd Monday prior**)

Voters that will be absent – Voters that will absent from their home residence between April 17th & May 9th, may contact their Respective County Clerk or Election Commissioner’s Office to make arrangements for early voting.

Applications will be accepted until May 1st.

Ballot Return Deadline - Voted ballots that are sealed in the “Return Identification Envelope” may be returned by one of the following means:

1. By US Mail – place 63 cents postage on the envelope to mail the ballot back.
2. Hand Deliver – the ballot to your respective County Clerk or Election Commissioner. Saunders County Clerk’s office, 433 N. Chestnut, Courthouse, third floor, Suite 300, Wahoo. Seward County Clerk, 529 Seward St #205, Seward, Lancaster County Election Commissioner, 601 N 46th St, Lincoln, Butler County Clerk, 451 N 5th, David City.
3. Place the ballot in your County’s Respective Secured Drop Box(es).

NOTE: All ballots must be in the possession of the Your Respective County Clerk or Election Commissioner no later than 5:00 p.m. on Election Day, May 9, 2023
