

**NOTICE OF SPECIAL ELECTION
TO EXCEED PROPERTY TAX REQUEST AUTHORITY
SAUNDERS COUNTY SCHOOL DISTRICT 78-0001
commonly known as ASHLAND-GREENWOOD PUBLIC SCHOOLS
IN THE STATE OF NEBRASKA
Tuesday June 10, 2025**

I, Dee Anne Nice, Saunders County Clerk, am calling for a special election to be held Tuesday, June 10, 2025, for a vote on whether Saunders County School District 78-0001, commonly known as Ashland-Greenwood Public Schools is authorized to exceed its property tax request authority for fiscal year 2025-26 by not more than \$1,300,000. The election is being called pursuant to Neb. Rev. Stat. § 79-3405, after receiving a recommendation of the School Board.

At least 60% of voters voting on the issue at the special election must approve the measure for it to pass per § 79-3405.

“Shall Saunders County School District 78-0001 commonly known as Ashland-Greenwood Public Schools, be authorized to exceed its property tax request authority for the fiscal year 2025-26 by not more than \$1,300,000, which amount shall remain below the maximum levy limit?”

- FOR authority to exceed annual property tax request authority in said amount
- AGAINST authority to exceed annual property tax request authority in said amount

Qualified electors voting in favor of the proposition shall blacken the oval opposite the words “FOR authority to exceed annual property tax request authority in said amount” following such proposition, and qualified electors voting against the proposition shall blacken the oval opposite the words “AGAINST authority to exceed annual property tax request authority in said amount” following said proposition.

By-Mail Election – This election will be an election by mail. All registered voters residing within the Ashland Greenwood Public School District will receive their ballot by mail at their address as it appears on the voter registration register and therefore no polling places will be open for voting. Ballots will be mailed by your respective County Clerk. Saunders County Clerk or Cass County Clerk, between May 19, 2025 and May 30, 2025.

Voter Registration Deadlines –

1. **May 23rd** - is the last day for mail in registrations, registrar registrations, delivered registrations and agency registrations Online Registrations prior to midnight. (**3rd Friday prior**)
2. **May 30th** - is the last day for in person voter registration in the office of the Election Commissioner or County Clerk (**6:00 p.m. 2nd Friday prior**)

Voters that will be absent – Voters that will absent from their home residence between May 19th & June 9th, may contact their Respective County Clerk or Election Commissioner’s Office to make arrangements for early voting.

Applications will be accepted until May 30th.

Ballot Return Deadline - Voted ballots that are sealed in the “Return Identification Envelope” may be returned by one of the following means:

1. By US Mail – place 73 cents postage on the envelope to mail the ballot back.
2. Hand Deliver – the ballot to your respective County Clerk. Saunders County Clerk, 433 N. Chestnut, Courthouse, third floor, Suite 300, Wahoo, NE 68066. Cass County Clerk, 346 Main St, RM#202, Plattsmouth, NE 68048
3. Place the ballot in your County’s Respective Secured Drop Box(es).

NOTE: All ballots must be in the possession of Your Respective County Clerk no later than 5:00 p.m. on Election Day, June 10, 2025
