Notice is hereby given that due to the recall of Doris Karloff, a vacancy exists on the Saunders County Board of Supervisors in the District #2 position.

**DISTRICT #2** - is comprised of all of Union Township (including the City of Yutan), Marble Township, Clear Creek Township (including the Village of Memphis) (excluding Sections 31, 32, that part of Section 27 lying South of County Road A, that part of Section 34 lying East of Industrial Road and all of Section 35 (13-9)), plus all that part of Ashland Rural Township lying North of Clubhouse Drive and Granite Way, in Iron Horse Subdivision and North and East of the North line of the corporate limits of the City of Ashland.
