Recognition of Veteran of the Month

Mary Pace, of Cedar Bluffs was recognize as the "Veteran of the Month for February". While stationed in Bad Kreuznach, Germany, she met and married her husband Tim. AltEn reported that a frozen pipe lead to the discharge from the digesters at the plant, which released storage materials and cattle manure. Staff from AltEn used plastic sheeting and haybales to try to contain the spill in the waterway. Nebraska Department of Environment and Energy (NDEE) is not sure if the spill contains pesticides and that it will take a couple of weeks to be determined from samples taken of the spill.
