



BOARD OF SUPERVISORS PROCEEDINGS March 9, 2021

Pursuant to adjournment, the Board met with Hrdlicka, Smaus, Albrecht, Lutton and Karloff present. Breunig and Sukstorf were excused.

Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairperson Karloff called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

Chairperson Karloff called for a moment of silence in honor of Steve Mika, Saunders County Public Works Director who a passed away March 5, 2021.

Recognition of Veteran of the Month

Richard 'Dick" Potter of Valparaiso was recognized as the "Veteran of the Month for March". Mr. Potter served in the Army from September 1968 to July 1970. Upon completing Basic Training and AIT, he was sent overseas to Vietnam as an infantryman later becoming a motorman (he was a point man and machine gun operator). Mr. Potter was discharged from the Army, July 24, 1970 as an E5/SGT. His awards included the National Defense Service Medal, Vietnam Service Medal, Vietnam Campaign Medal, ARCOM, Bronze Star Medial, the Air Medial and the combat Infantry Badge. Qualifications for the "Air Medal" are (3) enemy aircraft in flight confirmed and destroyed, (25) operational flights during which exposure to enemy fire is expected and (100) operational flights during which exposure to enemy fire is awarded to those that were under fire with the enemy forces in a combat zone.

Mr. Potter returned to Nebraska to help his dad with the farm. He met his wife Marica and for the last 50 years she has been at his side. They have (2) daughters and (2) sons and (13 grandchildren.

Mr. Potter has been a member of the Cattlemen's Association; a member of the VFW and American Legion in Valparaiso (currently serving as the Vice Commander); he is also a member of the elite group of American Legion Members called 48-8 (their work with charities has been remarkable); and a member of the Knights of Columbus.

repair, with the remaining amount being cost shared between the County and the NRD of each paying around \$60,000 each.

Eric Gottschalk, General Manager for Lower Platt North NRD – provided the Board with an update report on Lake Wanahoo operations and the recreation area for 2019 and 2020. He also provided the Board with a list of things that the NRD was looking ahead at for the next season. He also reviewed (6) other projects the NRD has in Saunders County.

Motion by Breunig, seconded by Hrdlicka to award the bid to Western Engineering Co., Inc., Harlan, IA, for the (2) Asphaltic Concrete Overlay Projects: 1) C-78(853) on County Road K between County Road 9 and 10; and 2) C-78(854) on Sunburst Lane Between Girmus Drive and County Road 10; as low bidder.
