- ~Contractor Project (704) Federal Aid Bridge 4 Span 175' continuous concrete slab bridge. Contractor is working on Abutment 1. Poured Abutment 2 6.10.24
- ~Contractor Project (850) County Road 13&14&F Triple 12'x12'x56' Seeding started Thursday (8/1/2024), seeding job is 1/6 complete. Will continue next week
- ~Contractor Project (849) County Road 30&B&C 91'9" Triple Span deck slab bridge. North side of bridge grading is coming along. South bridge abutment Deadman was poured Monday 8.5.24
- ~Contractor Project (847) County Road 24&25&S Triple 12'x10'x44' CBC on 20° skew LHB Floor was poured Wednesday 7.31.24, currently working on wall forms and rebar. The contractor plans to pour walls on Friday 9.9.24
