BOARD OF SUPERVISORS PROCEEDINGS November 26, 2024

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, John Zaugg, Scott Sukstorf, Frank Albrecht, John Smaus and David Lutton present.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairman Lutton called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

Public Works Director reported on the following:

~Dirt Crew - Working at Q&R&Railroad Dr. fixing the outlets of culverts. Will be moving to County Road A&19 to

Regrade ditch and remove some trees

~Culvert Crew – Will be working at Project (630) County Road 12&13&B installing Triple 96"x43' CMP with steel headwalls on 20° skew (LHB). Will be moving to 8&9&Little Salt Road to remove bridge and install a temporary

~Contractor - Project (322) Federal Aid Bridge - County Road 31&G&H, 130' Continuous concrete slab bridge. Contractor poured the deck of the bridge on Friday 11/22/24. Concrete must be cured for 10 days before the contractor can start removing forms and working on guardrail

~Contractor - Project (875) County Road 4&Industrial Road&A 150' concrete slab bridge on a 0° skew. The contractor Started mobilizing last week

~Contractor - Project (856) County Road 7&M&N Triple 12'x12' CBC on 15° skew LHB. Contractor plans on starting the project on December 2nd

~NDOT continuing work on the Round a bout Hwy 77, 92, 109 Junction

Motion by Reece, seconded by Zaugg to accept the proposal of TripMaster for a 3 year contract in the amount of \$33,920.00 for software that is now required by NDOT for scheduling, also purchase of tablets and data plan as submitted by the County Transportation Department. Helen Raikes & Karen Stille spoke to the Board about their application for Saunders County Economic Development Grant Funding for Ashland-Greenwood Area Communities for Kids (AGA C4K).

Motion by Sukstorf, seconded by Hrdlicka to approve the minutes of the November 19th Board Meeting and the Fee/Activity Reports for the month of October, 2024. Voting yes were Sukstorf, Albrecht, Smaus, Lutton, Reece, Hrdlicka and Zaugg. Voting no were none. Motion carried.
