BOARD OF SUPERVISORS PROCEEDINGS December 17, 2024

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, John Zaugg, Scott Sukstorf, Frank Albrecht, John Smaus and David Lutton present.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Public Works Director reported on the following:

~Dirt Crew – Working at County Road A&19 regrade ditch and remove some trees. Will be moving to County Road T&17&18 repair the back wall of a bridge.

~Culvert Crew – Will be working at Project (630) County Road 12&13&B installing Triple 96"x43' CMP with steel headwalls on 20° skew (LHB). Will be moving to 8&9&Little Salt Road to remove bridge and install a temporary culvert

~Contractor – Project (875) County Road 4&Industrial Road&A 150' concrete slab bridge on a 0° skew. The test pile has been driven for abutment 1 and bent 1, all bottoms have been driven for bent 1, pile has been ordered for both structure. The contractor will be driving 75' piling.

~Contractor – Project (856) County Road 7&M&N Triple 12'x12' CBC on 15° skew LHB. The existing structure was completely removed and excavation for diversion and box has started.

~NDOT Round a bout Hwy 77, 92, 109 Junction is open to traffic

Motion by Smaus, seconded by Hrdlicka to authorize the Highway Department to advertise for bids for the construction of a concrete deck slab bridge and related incidental work. Project "STWD-DBMP(7): C-78(859)" located on County Road L between County Road 27 and County Road 28. Bids to be opened January 7, 2025.
