## BOARD OF SUPERVISORS PROCEEDINGS March 18, 2025

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, John Zaugg, Robert Thiessen, Frank Albrecht, John Smaus and David Lutton present.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairman Lutton called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

Public Works Director reported on the following:

- ~Dirt Crew Started mobilizing equipment at the Ceresco Tower Site. Will be moving to Tough Tower Site when The Ceresco site is completed
- ~Culvert Crew Will be moving to Project 848 County Road 13&14&E Twin 84"x46' CMP with steel headwalls on 20° skew LHB. Project 877 County Road 18&e&F Triple 108"x56' 20° skew LHB CMP with headwalls is being delivered this week
- -Contractor Project (875) County Road 4&Industrial Road&A 150' concrete slab bridge on a 0° skew. False work is done and floorforms are down, shim shots were taken today. Will continue forming bridge deck this week and form up approaches and possibly pour approaches Friday
- ~Contractor Project (856) County Road 7&M&N Triple 12'x12' CBC on 15° skew LHB. Back fill is done and working On grading and filling in diversion. Will continue to completion this week, will get measured for seed this week
- ~Contractor Project (322) County Road 31&G&H (Federal Aid Bridge) 130' continuous concrete slab bridge. The Grading is on hold till March due to ground being frozen

Motion by Smaus, seconded by Hrdlicka to open bids for "Applied Traffic Paint Striping" at 9:06 a.m. Voting yes were Reece, Hrdlicka, Zaugg, Thiessen, Albrecht, Smaus and Lutton. Voting no were none. Motion carried.

One bid was received from Straight Line Striping, Grand Island, NE

Motion by Hrdlicka, seconded by Albrecht to accept the bid from Straight Line Striping, Grand Island, NE in the amount of \$128,560.00. Voting yes were Hrdlicka, Zaugg, Thiessen, Albrecht, Smaus, Lutton and Reece. Voting no were none. Motion carried.

Motion by Zaugg, seconded by Thiessen to authorize the Chairman to sign Approval of Certificates & Assurances for 2025-2026 Funding for County Transportation. Voting yes were Zaugg, Thiessen, Albrecht, Smaus, Lutton, Reece and Hrdlicka. Voting no were none. Motion carried.

Amber Scanlon, County Treasurer gave the Board her report of the County Tax Sale that was held on March 3, 2025. There were 40 pre-registered bidders. There were 115 Certificates processed. There are 11 outstanding parcels, 8 of which are already on County Tax Sale.

Director of Facilities and Grounds reported on the following: ~Inspection of roof was done last Thursday, bid of \$14,900.00

Motion by Reece, seconded by Smaus to accept the proposal from McKinnis Roofing in the amount of \$14,900.00 for repair of the Courthouse roof. Voting yes were Thiessen, Albrecht, Smaus, Lutton, Reece, Hrdlicka and Zaugg. Voting no were none. Motion carried.

Caleb Fjone, Executive Director, Ashland Area Economic Development Corporation spoke to the Board about Placer.ai, Placer.ai is a location analytics company that collects location data from mobile devices, this allows Communities to gather tourism data, economic development data, etc. The Ashland Area Economic Development Corporation used their economic grant last year to pay for this service and it has been beneficial to them. They would like the Board to think about getting on board with it this year as it would be beneficial to the County as all Cities and Villages would have access to the information. The Board would like to wait at this time.

Samantha Bure, Director of Wahoo APACE would like the approval of the Board to update the kitchen in the APACE building as it is a County owned building. The Board would like to see the plans. This project would be paid for with fundraising dollars.
