## BOARD OF SUPERVISORS PROCEEDINGS April 1, 2025

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, John Zaugg, Robert Thiessen, Frank Albrecht, John Smaus and David Lutton present.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairman Lutton called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

Public Works Director reported on the following:

- ~Dirt Crew Working at the Ceresco Tower Site. Will be moving to Tough Tower Site when the Ceresco site is completed
- ~Culvert Crew Will be moving to Project 848 County Road 13&14&E Twin 84"x46' CMP with steel headwalls on 20° skew LHB. Project 877 County Road 18&e&F Triple 108"x56' 20° skew LHB CMP with headwalls is being delivered this week
- ~Contractor Project (875) County Road 4&Industrial Road&A 150' concrete slab bridge on a 0° skew. Poured bridge approaches Wednesday 3.26.25 and Bridge deck Friday 3.28.25. Contractor will start stripping forms this week if the bridge deck has a good 7 day break
- ~Contractor Project (856) County Road 7&M&N Triple 12'x12' CBC on 15° skew LHB. Contractor was working on grading, finishing up Friday 3.28.25. Rock was delivered and seeding has started. Road should be open to the public this week.
- ~Contractor Project (322) County Road 31&G&H (Federal Aid Bridge) 130' continuous concrete slab bridge. The Contractor's working days count will start on April 7, 2025
