## BOARD OF SUPERVISORS PROCEEDINGS May 20, 2025

Pursuant to adjournment, the Board met with Bill Reece, Tom Hrdlicka, Frank Albrecht, John Smaus and David Lutton present. John Zaugg and Robert Thiessen were out of the room during roll call.

Notice of the meeting was given in advance by published notice in a legal newspaper as shown by the proof of publication filed in the County Clerk's office. Notice of the meeting was emailed to all members of the Board and a copy of their acknowledgement of receipt of notice and agenda is attached. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public, except when in closed executive session.

Chairman Lutton called the meeting to order at 9:00 a.m. informed the public of the location of the posting of the Open Meetings Act & Title VI Policy Statement are posted on the North wall (right hand side) as you enter the Board Room).

John Zaugg and Robert Thiessen now present.

Public Works Director reported on the following:

~Dirt Crew - Trimming and removing trees for Project (600). Will be moving to Cedar Bluffs tower site to repair road

~Culvert Crew – Working at Project (739) - County Road 32&M&N Installing Twin 84"x8' CMP with headwalls on 0° skew. Will be moving to Project (615) – County Road 7&8&Q Installing 72"x50' CMP with steel headwalls

~Contractor – Project (875) County Road 4&Industrial Road&A 150' concrete slab bridge on a 0° skew. Last week, the contractor graded roadway and ditches on east side of bridge. This week the contractor will grade roadways and ditches on west side of bridge

~Contractor – Project (322) County Road 31&G&H (Federal Aid Bridge) 130' continuous concrete slab bridge. Last Week the contractor armored banks and installed culverts on the south end of the project. This week Contractor will Continue grading the roadway and ditches. Guardrail is being installed weather permitting

~Flat roof part of the LEJC- insulation is buckling - not leaking right now - will get bids - insurance will not cover

Motion by Reece, seconded by Hrdlicka to authorize advertising for bids for bathroom to be opened July 1<sup>st</sup>. Voting yes were Zaugg, Thiessen, Albrecht, Smaus, Lutton, Reece and Hrdlicka. Voting no were none. Motion carried.
